On the ground of religion, caste or race, place of birth or any of them.

7. The School shall ensure:

- No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
- (ii) No child shall be subjected to physical punishment or mental harassment.
- No child is required to pass any board examination till the completion (iii) of elementary education.
- Every child completing elementary education shall be awarded a (iv) certificate as laid down under Rule 22.
